Course highlights

Funding

Levy Paying Employers

If your annual payroll exceeds £3 million, as a levy-paying employer, you will contribute 0.5% of your total annual payroll into your Apprenticeship Levy account. These funds can be accessed through your Digital Apprenticeship Service (DAS) account to pay for apprenticeship training. Additionally, you have the option to transfer up to 50% of your levy to another employer.

Levy Transfers

Levy-paying employers can support apprenticeships by transferring up to 50% of their unused levy to another employer.

The transferred funds cover 100% of the training and assessment costs of the apprenticeship, up to the maximum funding band.

Transferred funds will cover the entire duration of the apprenticeship programme.
