

UKVI REQUIREMENTS FOR STUDENTS

Work Regulations:

Term Time:

- Maximum of 20 hours/week (full-time degree students).
- Limited to roles that comply with visa conditions.

Holidays:

- Full-time work permitted during official university breaks.
- Cannot engage in professional sports or permanent positions.

Attendance and Engagement:

- Mandatory regular attendance for all scheduled classes, seminars, and assessments.
- Non-attendance may lead to visa curtailment.
- Universities are required to monitor and report non-compliance to UKVI.

Academic Progress:

- Students must demonstrate satisfactory academic progress throughout their studies.
- Engagement with all course requirements (e.g., submission of assignments, participation in exams).

UKVI REQUIREMENTS FOR STUDENTS

Proximity of Residence:

- Students must live within a reasonable commuting distance of the university. a maximum 90 minutes travel time and/or a 60-mile radius of the University campus
- Living too far away may be seen as non-compliance and reported to UKVI.

Address/Contact and Passport Information:

- Students must keep their home address and UK mobile contact details up to date with both the university and UKVI.
- Any change in address must be reported promptly.
- Students must let us know if they have a new passport

Health Insurance:

• Immigration Health Surcharge (IHS) provides access to NHS services, but students must remain registered with a GP.

Visa Compliance and Reporting:

- Any breach of visa conditions, such as excessive work hours or failure to attend classes, may lead to visa revocation.
- Universities are legally obliged to report all non-compliance to UKVI.
- Students should let us know immediately if they have a change of immigration status

Debt

- Students must keep up with any tuition fee payment plans arranged with the university.
- Failure to pay tuition fees may result in the university withdrawing the student from the course,
- which can trigger the withdrawal of the CAS and notification to UKVI.
- · Graduate visa cannot be obtained whilst in debt.

As a Student Visa
Holder, you must
remain in the UK
and engage with
your course of study
during term time



You may only travel in termtime in exceptional circumstances.

Before travel, an authorised absence request form must be completed by your Personal Tutor and considered by the International Student Support Officer and the UKVI team.

Never book your tickets before your travel is authorised



If you are outside the UK for an extended period of time which will mean you missing teaching and/or assessment, this may have implications for your Student Visa





CULTURE SHOCK

'Culture shock' describes the impact of moving from a familiar culture to one which is unfamiliar. This can affect anyone and is quite normal. Your fellow international students will share the experience but so will many UK students who are away from home for the first time.

If you experience culture shock it does not mean you made a wrong choice in coming to Bolton. Our dedicated international student support team is here to help you in all aspects of support you may need.


